**SHALL THE FOLOWING PUBLIC MEASURE BE ADOPTED?**

"Shall the Board of Directors of the Bettendorf Community School District, in the County of Scott, State of Iowa, be authorized to levy a voter-approved physical plant and equipment property tax not exceeding one dollar and thirty-four cents (\$1.34) per thousand dollars of assessed valuation for a period of ten (10) years, (commencing at the expiration of the current voter-approved physical plant and equipment levy on July 1, 2004) to be placed in the physical plant and equipment levy fund and expended for the purchase and improvement of grounds; the construction of schoolhouses or buildings and opening roads to schoolhouses or buildings; the purchase of buildings and the purchase, lease or lease-purchase of equipment or technology authorized by law; the payment of debts contracted for the erection or construction of schoolhouses or buildings, not including interest on bonds; procuring or acquisition of library facilities; repairing, remodeling, reconstructing, improving or expanding the schoolhouses or buildings and additions to existing schoolhouses; expenditures for energy conservation; the rental of facilities under Chapter 28E; purchase of transportation equipment for transporting students; lease-purchase option agreements for school buildings and for equipment; equipment purchases for recreational purposes; payments to a municipality or other entity as required by law; and all other lawful purposes?"
