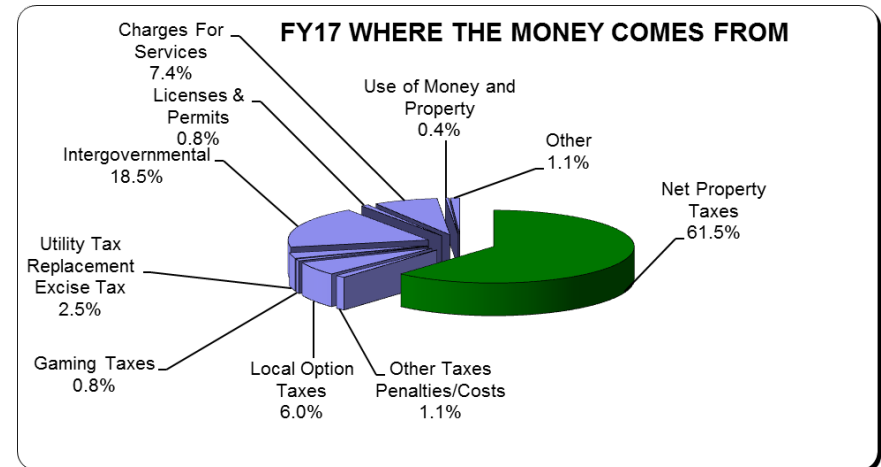
### AWARDS
