

## STAFF EDUCATION

The nurse provides education and consultation to school staff on a variety of health topics upon request.



### **MEDICATION ADMINISTRATION**

Medication Administration training is required for school staff who deliver medications to students. This certification allows non-medical staff to administer medications to students in Iowa schools and is updated periodically.

### **STOP THE BLEED**

Education and hands-on experience regarding how to use tools to stop life-threatening bleeding during trauma for staff designated by the principal.



### **BLOODBORNE PATHOGENS**

Standard Precautions training is mandated annually for school staff. Training video will be provided to schools that are not contracted with the AEA.

### **COMMUNICABLE DISEASES**

Regularly provides consultation related to communicable diseases, prevention of disease spread, and recommendations for maintaining a healthy school environment.



### **STUDENT HEALTH PLANS**

Education to school staff on proper implementation of individual student health plans (allergies, asthma, diabetes, etc).

# **Non- Public School Health Services**

## SERVICES WE PROVIDE:

### REGISTRATION & KINDERGARTEN/PRESCHOOL ROUND-UP

The nurse attends registrations and/or Kindergarten/Preschool round-up at the school's request. Services include collection of immunization and health records, distribution of medication administration forms, and dissemination of health information to parents and students.

### HEALTH RECORD COORDINATION

The nurse reviews student health records and assists with health plans when appropriate.



### PREPARATION FOR DENTAL & IMMUNIZATION AUDIT

The nurse reviews records to prepare for the annual immunization and dental audits. The nurse also evaluates compliance with state requirements and contacts parents to obtain required information. If a student has not met mandated record requirements, the nurse notifies the principal who is ultimately responsible for compliance requirements.



### SCREENING ACTIVITIES

The nurse provides various health screenings for students. These services are provided annually upon request from the principal.

#### VISION SCREENING

The nurse offers vision screening for students at recommended grade intervals. The nurse will screen any student by request if there is a concern.



#### DENTAL SCREENING

The nurse offers dental screening for students in kindergarten. The nurse will screen any student by request if there is a concern.

#### HEARING SCREENING



The Area Education Agency provides hearing screenings for students in schools under their contract. The nurse offers hearing screening for students in schools not contracted with the AEA. The nurse will screen any student in schools not contracted with the AEA if there is a concern.

### HEALTH EDUCATION

The nurse provides education to students and parents upon request. This includes various topics and may be scheduled throughout the school year.

#### PARENT EDUCATION

Parent education may include individual education regarding health concerns or group education such as an overview of maturity education.

#### MATURITY/PUBERTY EDUCATION

An overview of changes associated with puberty may be provided to 4th and/or 5th grade female students.



### CLASSROOM EDUCATION

The nurse can link outside resources and/or provide opportunities for classroom education including hand washing, dental hygiene, tobacco awareness or other health-related topics which may be requested.
