### Chapter 6-Zoning for Unincorporated Areas

17-04 An Ordinance to amend the zoning map by rezoning approximately 3.93 acres in Section 6, Butler Township from Neighborhood Commercial (C-1) to Commercial-Light Industrial (C-2), all within unincorporated Scott County.

17-06 An Ordinance to amend the zoning map by rezoning approximately 2.23 acres in Section 26, Blue Grass Township from Residential Single-Family (R-1) to Commercial-Light Industrial (C-2), all within unincorporated Scott County.

18-06 An Ordinance to amend the zoning map by rezoning approximately 3.56 acres in Section 5, LeClaire Township from Agricultural-Preservation (A-P) To Single-Family Residential (R-1), all within unincorporated Scott County.
